2012 Review / 2013 Event Meeting

- 2. Shifter Karts: Do we want to continue shifter karts from a safety perspective at certain venues? After discussion a motion was made to allow shifter karts with the proposed rules. If running a shifter kart, the driver must have either 2 years experience autocrossing a car or 1 year experience racing a shifter kart. This will apply to all venues. The motion passed.
- 3. Minor Participants: Alicia would like a measuring stick in registration. Jerry Braunberger will place a mark on the side of the registration trailer.
- 4. Rule Changes: Alicia asked that the rules be modified to include "no motorized pit bikes are allowed in grid".
- 5. Radios: There was a discussion about having better radio equipment for the workstations. Higher quality regular batteries will be used in place of rechargeable batteries. Headsets purchased when needed. The current radios will be tested, discarded if bad and replaced with new
- 6. Having Fun: Alicia and Ruben Cruz gave us the "talk". If something happens that you're not happy with then go through proper channels. If you're out here to not have fun, then you shouldn't be there. Always be respectful to others. We need to think of ways to reward volunteers and make it fun
