Old Business

She did have an answer at that moment.

John Schmidt went over what he plans to show and discuss with his presentation. (I could not keep up with him)

Venues & Schedule – Lorin Wamsley – VRC is confirmed for Ice Breaker and event 7&8. Its tentative for event 1&2. HooDoo has been requested for event 3&4 and 5&6, with WP as a backup for 5&6.
