



Meeting Notes  
December 5, 2001

President Cheryl Baugh called the meeting to order at 7:02 p.m.

Bill Baugh volunteered to check on the cost of an insurance policy.

Jim Mueller reported receiving a letter from K&K Insurance stating that there was talk of our premium increasing in the future.

The generator purchased at Grainger in April needs to be returned for repair while under manufacture warranty.

The timing trailer needs to be finished. We need to organize a work party to get this done during the off season.

It is everyone's responsibility to recruit sponsors for events. Ask Jim Mueller or Lorin Wamsley for sponsor information packets.

Debbie Steck volunteered to print up business cards for officers to hand out. The reverse side will have our event schedule.

Name badges need to be made for officers and chairpersons to be worn at the events thus they are easily recognized by newer members.

Tim Thoming stated he is willing to put together a showing at the Race Central Swap Meet for February 2002.

Cheri Wilson volunteered to do trophy presentations at autocross events.

Helmet bags not distributed at the banquet will be mailed at the next flyer party.
