- Tim Steck has proposed a new system for EESCC to determine winners and their position at the end of year. A motion was presented, it was seconded and passed. The proposed system is as follows:

Some basic criteria:

- To trophy the drivery must participated in a minimum of 5 events even if they were NFT for some events (ran out of class).
- > To trophy in a particular class the driver must have at least two events in that class

To determine which class they get their trophy in:

- 1. Their highest finish in the qualifying classes
- 2. If the highest finish position was the same for more than one class, then the class they participated the most events in.
- 3. If the highest finish position and the number of events in each were the same, then the class with the highest number of year end points.
- 4. If everything is identical, then the class with the highest PAX number. This would be the "fastest" class.

To determine the position within a class:

After the class for each participant has been determined the order within the class is re-numbered based on total year-end points for each participant in that class.
