

Meeting Notes May 5, 2004

The meeting was called to order by President Brad Moffett at 7:00 p.m. Secretary Cheryl Baugh read the April meeting minutes. They were approved as read. Jim Mueller presented the treasurers' report.

## **Old Business**

- Pat Ezard has a catalytic heater and Bonnie and Jim Mueller have a propane tank we could use in the registration trailer.
- Jerry Braunberger will make steps for the timing trailer.
- Several of our club members went to Atwater. They reported it was fun and hot! The course was fast and technical with a whole lot of pavement.
- It was suggested that the switches on the timer be changed to push buttons. Brad Moffett volunteered to get this done.
- Matt Bueler reported that he went to the Medford event and it was a lot of fun.. He also attended the Redmond event and had a great time there too.

## New Business

- Articles for the newsletter: Brad Moffett is assigned May, David Lumbra June, and Bonnie Mueller July.
- Bonnie Mueller brought up noise limit concerns. We want to limit our noise level to 96 dbs. We will be using a sound meter at the next event and monitor every car.
- Jordan Weist suggested that if the db level exceeds 98 the driver is out. Bonnie Mueller will make signs and Jordan Weist will be the noise monitor.
- Signs will be made for our Valley River Center venue. We want the spectators to stay away from specific areas.
- Brad Moffett mentioned trophies are not real clear. Several people stated there was a lot mentioned about the sponsors and very little about 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, etc. place. The trophies should be more meaningful to the trophy winner.
